## iGAMING VOLUNTARY EXCLUSION REQUEST

The Pokagon Band Gaming Commission (“PBGC”) is an independent government gaming regulatory authority tasked with oversight of all **Four Winds Casino** online real money gaming and online sports betting (collectively hereinafter “iGaming”) and additionally administers the iGaming Self-Exclusion program.

By the submission of this *iGaming Voluntary Exclusion Request*, one’s name would be added to the iGaming Exclusion List, prohibiting that person from participating in any Four Winds’ iGaming for a **minimum of two (2) years**; any 2<sup>nd</sup> iGaming Exclusion request shall result an irrevocable lifetime exclusion. Please Note: This form is intended for **online iGaming** Self-Exclusions and will ***NOT*** result in exclusion from live gaming at any Four Winds Casino property in Michigan or Indiana. If Self-Exclusion from casino properties is desired, please appear at any property and request to speak with the Gaming Commission.

This form is intended for *Self-Exclusion* only; any requests submitted on behalf of another person shall not be honored.
