Proposed Revision of the Pokagon Band Gaming Commission Regulations

Notice of Intent

- **Copy of Proposed Regulations (attached)**
- **Description of the Nature**
 - Chapter 1 Definitions is amended to align terminology in the Regulations with terminology outlined in the Pokagon Band Gaming Regulatory Act and to define terms utilized in proposed amendments in Chapters 2.
 - Chapter 2 Supplier Licensing is amended to outline requirements for licensure of gaming suppliers and non-gaming suppliers, remove the option of mailing a License Application to the Commission, outline the determination process applied by the Commission in revocation, suspension, or renewal of a license, and provide for licensure of non-gaming supplier representatives not otherwise required to the licensed by the Commission.
 - Chapter 4 Minimum Internal Control Standards and Chapter 5 Gaming Devices are amended to align the Regulations with updates to the National Indian Gaming Commission (NIGC) recommended Minimum Internal Control Standards.
 - Chapter 14 Internet and Mobile Gaming is amended to reduce duplicity in the Regulations and align the Regulations with Internet and Mobile Gaming offered by the Casino Operator.
- **Effect of the Proposed Regulations**
 - The amended definitions contained in Chapter 1 Definitions are intended to align terminology in the Regulations with terminology outlined in the Pokagon Band Gaming Regulatory Act and to define terms utilized in proposed amendments in Chapters 2.
 - The amended language in Chapter 2 Supplier Licensing is designed update the Regulations with current practice in processing Gaming License Applications, clarify the determination process applied by the Commission in revocation, suspension, or renewal of a license, and provide for licensure of non-gaming supplier representatives not otherwise required to the licensed by the Commission, but whose responsibilities permit them access to non-public areas of the Gaming Operation.

- The amended language contained in Chapter 4 Minimum Internal Control Standards and Chapter 5 Gaming Devices is designed to incorporate updates to the National Indian Gaming Commission's (NIGC) recommended Minimum Internal Control Standards.
- The addition of Chapter 14 Internet and Mobile Gaming is intended to reduce duplicity in the Regulations and align the Regulations with Internet and Mobile Gaming offered by the Casino Operator.
